The Midwest's finest outdoor Jazz festival is **FREE to attend** and offers an exciting lineup of world-class Jazz performers.

The festival also features a variety of wines from local vineyards, as well as a selection of delicious food from local restaurants. Due to the overwhelming success of the festival in year's past (more than 5,000 people in attendance), 2015's event will see the addition of an ART WALK, featuring local and regional artists of all styles and mediums.

The evening will end with an amazing fireworks display, making the festival a great place to bring the entire family.

REQUIREMENTS

Submission of artist website and/or photos of artwork for review.

- All work must be original, handcrafted work. We encourage first-time exhibitors, but professional presentation is extremely important.
- No artwork from molds, kits or other commercial methods is allowed.
- If work is produced in editions, edition numbers must be disclosed to the event audience.
- All work must carry a selling price and exhibitors must produce enough work to have booth open all day.

- Artists must be present with their work for the entire time of event – no early breakdown will be allowed.
- If the work is collaborative, at least one collaborator must be present.
- All artists must check in upon arrival.
- An artist’s image may be selected for use on promotional materials including, but not limited to posters, postcards, flyers, advertising, and website.

BOOTH INFORMATION

The Art Walk will be located along Veteran’s Place Drive for a participation fee of \$250. Artists must provide their own tent along with chairs and booth supplies. Tents must be weighted but no anchoring stakes will be allowed. Artist booth must consist of a **“White” 10’ x 10’ tent**. Artists are responsible for all set up and tear down of their individual booth.

Silverman Music, LaDeDa Entertainment and City of Chesterfield and event associates are not responsible for any damage that may occur to artwork, equipment or other materials due to rain, wind, fire, theft, etc. Exhibitors shall not display, offer for view, sell or consume any illegal or contraband items. Unauthorized alcohol sales, illegal alcohol consumption and bringing any kind of alcohol or illegal substance into the Chesterfield Amphitheater is also prohibited.

SALES

- Artists are responsible for handling all sales of their artwork.
- Artists retain all revenue from the sale of their artwork with no commission due to Silverman Music, LaDeDa Entertainment or the City of Chesterfield.
- Artist is responsible for collection and reporting of all taxes, including Missouri sales tax.

VENDOR PAYMENT

Payments of \$250 must be mailed to the address below and made out to “Silverman Music”. We only accept check or cashiers check. There is no application fee. Additional charges may be applied based on individual artist needs (electricity, booth, tables, chairs, etc). If you are not selected, we will notify you immediately and return your payment. All applications with payment must be received no later than Wednesday, June 10th.

Proof of Insurance and/or Waiver of Liability WILL BE REQUIRED before any Exhibitor may set up.

Waiver of Liability and Hold Harmless Agreement

1. In consideration for participating in the Silverman Music, Inc event, Chesterfield Wine & Jazz Festival held at the Chesterfield Amphitheater, I hereby RELEASE, WAIVE, DISCHARGE AND COVENANT NOT TO SUE Silverman Music, Inc, LaDeDa Entertainment & Events, Chesterfield Amphitheater, the Board of Directors, City of Chesterfield, committee members, volunteers, sponsors or agents (Hereinafter referred to as RELEASEES) from any and all liability, claims, demands, actions and causes of actions whatsoever arising out of or related to any loss, damage, or injury including death, that may be sustained by me, or to any property belonging to me, WHETHER CAUSED BY THE NEGLIGENCE OF THE RELEASEES, or otherwise, while participating in such event, or while in, on or upon the premises where the activity is being conducted. I am fully aware of risks and hazards connected with the event, including but not limited to the risks as noted herein, and I hereby elect to participate in said event, and to enter the above named premises and engage in such event knowing that the event may have a crowd exceeding 6,000 participants. I VOLUNTARILY ASSUME FULL RESPONSIBILITY FOR ANY RISKS OF LOSS, PROPERTY DAMAGE OR PERSONAL INJURY, INCLUDING DEATH, that may be sustained by me, or any loss of damage to property owned by me, as a result of participating in such event, WHETHER CAUSED BY THE NEGLIGENCE OF RELEASEES or otherwise.

2. I / We (organization / company) hereby AGREE TO INDEMNIFY AND HOLD HARMLESS THE RELEASEES from any loss, liability, damage or costs, including court costs and attorney’s fees, that may incur due to my participation in said event, WHETHER CAUSED BY NEGLIGENCE OF RELEASEES or otherwise. I understand the RELEASEES do not maintain any insurance policy covering any circumstance arising from my participation in this event. As such, I am aware that I should review my insurance coverage.

3. It is my express intent that this Release and Hold Harmless Agreement shall bind the members of my family. If I am alive, and my heirs, assigns and personal representative, if I am not alive, shall be deemed as a RELEASE, WAIVER, DISCHARGE AND COVENANT NOT TO SUE the above named RELEASEES. I hereby further agree that this Waiver of Liability and Hold Harmless Agreement shall be construed in accordance with the laws of the State of Missouri.

4. I UNDERSTAND THAT SILVERMAN MUSIC, INC NOR LADEDA ENTERTAINMENT & EVENTS WILL NOT BE RESPONSIBLE FOR ANY MEDICAL COSTS OR PROPERTY LOSS ASSOCIATED WITH ANY INJURY OR LOSS I MAY SUSTAIN.

5. I further agree to become familiar with the rules and regulations of the Chesterfield Wine & Jazz Festival Agreement and not violate said rules of any directive or instruction made by the person or persons in charge of said event. I will assume the complete responsibility of any activity done in violation of any rule or directive or instruction.

6. I also understand that I must obtain adequate insurance to cover any personal injury to myself or property loss which may be sustained during the event.

IN SIGNING THIS AGREEMENT, I ACKNOWLEDGE AND REPRESENT THAT I have read the following Waiver of Liability and Hold Harmless Agreement, understand it and sign it voluntarily as my own free act and deed, no oral representations, statements or inducements, apart from the foregoing written agreement, have been made. I execute this document for full, adequate and complete consideration fully intending to be bound by the same.
